Many Questions About APPR Remain Without Answers

As all ATA members should be aware, New York State's new Annual Professional Performance Review (APPR) system is mandated to begin this year for 4th through 8th grade ELA and math teachers and next year for all other classroom teachers. We are now over a month into the school year and many questions remain, especially for those who will be rated this year under the new system. While some of these questions can be addressed at the district level since they concern items that must be locally negotiated, many issues remain unanswered with regard to the portions of the process that are controlled by the state. The following is an attempt to answer some questions that members have recently submitted.

When can the evaluation process begin for 4th through 8th grade math and ELA teachers?

It cannot begin until an agreement has been reached between the district and the ATA about all of the details of the evaluation process. We are currently in negotiations, but no agreement has been finalized.

How many times will I be observed?

The law says that teachers must be observed at least two times. Wording will be in place in the final APPR agreement with the district as to whether or not more observations can take place and how they will be counted toward the final score. This is still being discussed.

Will we have to submit a portfolio?

Aside from the portion of the APPR score based on state tests and observations, the other components must be negotiated with the ATA. While requiring teachers to submit a portfolio is an option, the ATA realizes that this is not preferable to many members and is presenting alternatives to the district, such as continuing with a PGP process like the one currently in place.

How will my APPR rating be completed if I am out on leave for part of the year?

That is a good question. While it is not specifically addressed anywhere in the APPR guidelines put out by the state, it is stipulated that the "teacher of record" for a particular student is the teacher who is "primarily and directly responsible for a student's learning activities." It is also stated that "the state expects to weight partial-course enrollment (or teacher assignment) differently than full-course, but does not plan to set a minimum time before a student is included in a course." It goes on to say that exactly how this weighting will be done will be defined through the work of the vendor assigned to perform the value-added analyses of test scores. These vague statements are the only answers we have on this topic right now.

How will the state test component of the rating be determined for teachers

Spotlight on the Contract: Half Days

"An additional one-half (1/2) day shall be scheduled when children will be dismissed and teachers will work on student assessments. Each elementary school administrator shall meet with the ATA representative prior to June 1 of the preceding school year to receive input when the one-half (1/2) day shall be scheduled for the upcoming year."

Explanation: According to this provision of the ATA contract (Article XII, page 15), all elementary schools will have one half day scheduled for the sole purpose of working on student assessments. The date for this day cannot be chosen by administration without input from the teachers. If a half day has already been scheduled at your school without the agreement of the teachers, or not for the purpose of working on student assessments, another one must be scheduled that follows the guidelines set forth in the ATA contract. The ATA is aware that this has happened at some schools and is working to remedy the problem.

who do not teach a course with a state test, such as art or music?

The APPR guidelines set forth by the state say that, "For these grades/subjects, districts will be required to engage in a state-determined district-wide process for student growth goal-setting that identifies some type of assessment of student learning and sets targets for student growth as measured by that assessment. "This can be interpreted as "we don't really know." This will have to be clarified by the state, theoretically before these teachers would have to be rated in the 2012-2013 school year.

Where can I find more information about the APPR process?

As soon as the locally-negotiated portions of the process are agreed upon the ATA will be sure to make all members aware of the details. A PDF document with the entire state guidelines can be found at http://usny.nysed.gov/rttt/ teachers-leaders/fieldguidance.pdf. It is rather lengthy, but it is searchable. For newer versions of Adobe Acrobat a search term (such as "teacher of record") can be typed in after clicking on the binoculars icon.

Negotiations Update:

The ATA met with the district and a mediator in September, but made little headway because of the district's intransigence. The mediator, whose role is to facilitate an agreement by encouraging the two sides to come off their original positions, concluded that the district was not making a serious effort to come to an agreement. As a result of that meeting, the ATA sent a letter to the Board of Education requesting that the district take the process of negotiations more seriously. No new meetings with the mediator are scheduled at this time.



Titusville

Larry Jeannotte recently earned his Ph.D. from Capella University with a specialization in Advanced Teaching K-12. His comprehensive examinations focused on curriculum development and survey research and his dissertation topic was the relationship of play to psychosocial development. In his study of 82 local college sophomores, he found that there is a statistically significant positive relationship between play and accomplishment of developmental tasks. Individuals who had higher total scores for play involvement and intensity had completed more developmental tasks than their less playful peers. Competitive play (either physical or mental) and imaginitive play correllated with increased development, while thrill-seeking activities and games of chance had little impact. He started his doctoral study because he was increasingly concerned that his students had fewer opportunities to play, both in their neighborhoods and at school.
