Lyons Shares His Outlook

In August Arlington's new superintendent Brendan Lyons sat down with The Educator to talk about his outlook for the upcoming school year. Lyons began his career with Arling-

ton in 1995 as a social studies teacher at the high school, progressing to assistant principal there, then principal of Ar-

lington Middle in 2003 and back to the high school as principal from 2010 until 2012, when he became deputy superintendent. Here are his responses to some of our questions:

Last year saw the introduction of the term "right-sizing" to Arling-

ton. Will that practice continue this year?

The last big class is in 8th grade this year and as they move up we've been cutting behind it. But sooner or later that big group

graduates and there is nothing left to right-size. As we look at our long-range fiscal future we will have to take some pretty drastic action to preserve all of those things that are important to the Arlington community as far out as we can. There will be some really tough decisions over

the next several years. If you have to cut what should it be? We have been in good shape. We may have been able to shift resources in the past, but the reality is that when we pro-

> ject that out over the next four or five years you see the cliff coming. The question is do you go whole -hog until you

can't anymore and then have massive cuts or do you cut a little bit each year so that when you get to that point it's not so dramatic? All of these are judgment calls. You try to balance being fiscally See Superintendent on Page 6

Negotiations Update:

As per our June 2012 contract settlement, the ATA agreed to negotiate with the district on the recalibration of our salary schedule. If agreement on a recalibrated salary schedule, which would only apply to newly hired members, is not reached by June 1, 2014, the current contract will expire on June 3, 2014. This is one year less than if an agreement is reached.

Spotlight on the Contract: Meetings

Each issue of The Educator will spotlight a particular part of our contract in an effort to make our members more familiar with their rights and the terms and conditions of their employment. If you have a section you would like to see featured, email sfalk@acsdny.org.

"Five (5) additional after school meetings per year not to exceed one hour and fifteen minutes for the purpose of teacher collaboration relative to improving student achievement. These meetings shall be for the purposes of Professional Learning Communities (PLCs), the establishment and discussion of student learning objectives (SLOs) and similar purposes. These meetings shall not be used as administrator led faculty meetings."

Explanation: According to this provision of the ATA contract (Article XII, page 17), members are required to attend five additional afterschool meetings per year on top of the faculty and department meetings that may be scheduled each month. A key difference is that these additional meetings must not be led by administrators, but only used for teachers to work together on tasks such as writing and grading pre- or post-tests.

Find Out if a Flex Plan is Right for You

A flexible spending account (FSA) allows you to pay for eligible medical and day care expenses with pre-tax dollars, thereby lowering your taxable income. I know that as a parent of three children, the flex plan offered by our district worked out well for my family as there was always somebody at a doctor's office for something.

What it is: A healthcare FSA allows

vou to set aside money on a pre-tax basis to pay for qualifying out-of-pocket health care, dental, vision or hearing expenses. Out-of-pocket expenses are those that are not covered by your existing insurance plans. For example, for years I was receiving allergy shots twice a week, with a \$15.00 copay every time I entered the office for shots. Having a flex plan enabled me to have money set aside to reimburse myself for these fees. Another common use of the healthcare FSA is for orthodontic expenses. Our plan allows for salary contributions between \$150 and \$2500 for the plan year.

A dependent day care FSA allows you to set aside money on a pre-tax basis to pay for child or adult day care expenses. These expenses include day care, before-and-after school programs, preschool, or summer day camp. Our plan allows for salary contributions between \$150 and \$5000 for the plan year.

Our plan year begins on October 1 and runs until the next September 30.

How it works: The amount of money you wish to set aside is deducted from your paycheck on a

pre-tax basis over 15 pay periods. This year that will be from October 25 until May 9. As you incur healthcare and/or dependent day care expenses throughout the year, you can access your funds by submitting an online reimbursement claim or by completing a paper claim form and submitting it via fax or mail.

You must re-enroll each year if you want to continue participating.

How to Participate in an FSA:

- ✓ Decide if you will be using a healthcare or dependent day care FSA, or both.
- ✓ Estimate the amount you spend on out-ofpocket health care expenses and/or dependent care expenses during a year.
- ✓ Decide how much you wish to set aside into your healthcare account and/or your dependent day care account, keeping in mind that unused funds are forfeited at the end of the plan year.
- ✓ Go to http://www.arlingtonschools.org/pages/ arlington_schools/Departments/ Human_Resources/Forms/FLEX_Benefit_Plan to obtain forms. You must be signed-up by September 27 for this plan year.
- ✓ Attend the informational meeting on September 16 at AHS in room 1432. There will be two sessions, one at 3 p.m. and another at 4 p.m. (This is strongly advised for first-time FSA participants.)

Benefits For You: If you have paid a large doctor bill (say \$2,000) you can collect it back even though your \$2,000 hasn't been completely collected from your salary yet. You can save on federal taxes and social security taxes as well as state income taxes. Generally, federal taxes range from 15% to 28% and social security taxes equate to 7.65%. Adding these amounts to

your state tax will generally bring your tax savings to approximately 30% on the money you elect to contribute to your FSA.

Potential Problems: A flex plan means that you will have to estimate your medical expenditures for the year. That can be difficult to do, and it's hard to anticipate medical issues. Please know that any funds left in your account at the end of

the year are forfeited. If you aren't someone that keeps and collects receipts, and aren't able to do a minimal amount of bookwork then think carefully before starting an FSA. We are allowed a 90 day "grace period" with which to use our FSA funds, but please note, the expenses must have been incurred between the Oct 1-Sept 30 enrollment. You can avoid forfeitures if you plan carefully by reviewing your prior year's out-of-pocket expenses to estimate what you will spend in the next year. Be conservative and plan only for predictable expenses for your first year.

NYS Art Teachers Association Summer Institute



Hudson Valley Writing Project Summer Institute

I attended the Invitational Summer Institute of the Hudson Valley Writing Project (HVWP) at SUNY New Paltz for four weeks in July. I worked with teachers across all subject areas and grade levels across the Hudson Valley. Together we read, wrote, instructed each other and discussed many issues facing today's learner and educator. EdCamp

Thirteen Arlington employees represented all levels of the district on August 20 at EdCamp, held at Ulster BOCES in New Paltz. EdCamp is a free, vendor-free "unconference" that is made up of sessions determined the day-of based on the interest of the participants. Some of the sessions included: apps for the classroom, using LiveBinder, digital storytelling, and project-based learning. What is particularly unique about this professional development is anyone can present or lead a discussion on anything he or she feels knowledgeable about.

Two ATA members, Kate Sprague Hicks (library media specialist at UMS) and Julie Jee (English teacher at AHS), led sessions. Hicks led the discussion about using the librarian at your school as an asset to your teaching, while Jee discussed the 80/20 "genius hour" she does with her class.

Physics of Atomic Nuclei (PAN)

During the last week of July Sam Falk (AHS) and I travelled to the University of Michigan's cyclotron laboratory to join 20 other science teachers from across the country in learning about nuclear astrophysics. It was fascinating to see how the topics that we teach at the most basic level in high school are applied in much greater detail by researchers investigating the greatest mysteries of the universe. Continued from Page 2 conservative and preparing for the future while also maintaining Arlington as a great district.

What would you say to those teachers low on the seniority list about their future at Arlington?

My advice would be, first, don't lose heart right away because in a large district like this there is natural turnover, whether it is from people resigning, retiring, or going on leave. We've been very lucky so far; there were very few people that permanently lost their jobs until this last school year. The second

thing is, as a professional, also don't be naïve. Don't wait until May to realize that you may not have a position. Polish up your resume and make sure you are ready to go. When things get more clear in the spring when the budget comes together watch, look, listen, and be informed: don't be a passive victim. Lastly, don't lose all hope. There clearly will be some layoffs at all levels if a school is closed, but as to how many, we're not into that level of detail yet.
