# Support the School Budget on May 16

This year's school budget vote will take place on Tuesday, May 16. The ballot will also include two propositions and three school board candidates who are running unopposed.

The support of every ATA member is vital to ensure a positive outcome to the budget process. If you do not live in the district it is important that you talk to your friends and family who do and encourage them to get out and vote on the 16th. Make sure to tell them why passage of the budget and the bus proposition and transportation and maintenance facilities propositions are important to you and how they will

benefit the children of this district.

In addition, offer to give them information about the candidates for school board and explain why it is important for the success of Arlington to have people on the school board who value public education and will support the children and staff of the district.

To the right and below you will find some facts to help you inform others about the 2017—2018 Arlington school budget, the bus proposition, and the transportation and maintenance facilities proposition. More information about these items can be found at arlingtonschools.org.

### **BUDGET FACTS**

- A 1.52% tax levy increase is proposed
- This is the sixth year in a row that Arlington's proposed tax levy has been below the cap
- If the budget fails twice, a contingency budget must be adopted, meaning that an additional \$1.38 million would have to be cut. That would require the elimination of new equipment purchases and many needed building repairs.

### **BUS PROPOSITION**

When school buses reach a certain age or number of miles NYS requires that they are replaced. Taxpayers are asked to permit the district to purchase new vehicles. This year's proposition is the same as last year, and with 61.8% eligible for state transportation aid ,the local share of the cost is \$719,497. If the bus proposition is not passed the district will have to lease buses, which will be more expensive.

### TRANSPORTATION & MAINTENANCE FACILITIES PROPOSITION

Last year Arlington taxpayers approved a capital reserve fund to allow the District to set monies aside for the purpose of constructing additions and making improvements to district facilities. This year they are asking for voter approval to use that money to make muchneeded improvements to transportation and maintenance facilities. This will not result in any additional increase to taxes.

Every spring, NYSUT's Representative Assembly gathers together delegates from each local union across New York State to take part in its policymaking process. This year the RA was held in Manhattan on Friday, April 7 and Saturday, April 8. Representing the ATA were President Bob Maier, Treasurer Dave Cordella, Second Vice President Steve Hertzog, Communications Chair Sam Falk, and members Donna Doerrier and Jim Lillis. The main business of the RA is for NYSUT to set priorities for the coming year and focus effort and resources on the issues that matter most to members, as decided upon by the committees of participating delegates during

the busy convention program. Every three years the RA also hosts elections for NYSUT officers, as it did this year.

The body of delegates, just like any large group of teachers, are often unified in their opposition to changes that have been imposed on us, like student testing, the receivership laws, and the possible NY Constitutional Convention in 2017. They can also have differing opinions on issues such as APPR and NYSUT election procedures. Because of this, time is taken at the convention to allow committees of members who are particularly interested in working toward change in each of these areas to meet and craft language that See RA on Page 3

### **Changes To Health Insurance Are Coming Soon**

As many of you have seen the notice in our payroll, I wanted to follow up with some explanation of the changes that will happen shortly with our Blue Cross / Blue Shield health insurance plans. Due to a computer/ software update at BC/ BS they will be changing our group numbers, not necessarily our individual ID numbers. In any event, it is very important that our members pay close attention to the changes that are coming.

First, we all will be receiving new health insurance cards in June that will become effective on July 1, 2017. The cards will look very similar to the ones we carry now for ourselves and our dependents. I have suggested to people to mark the cards you currently have with a marker or something that will stand out to you. This way there will be no confusion with the new cards when they arrive in June. So to be clear,

current cards are to be used up until the close of business on June 30. The new cards should be used for doctor visits, prescriptions, or hospitalization beginning July 1 by all participants and their dependents.

time, Davis Vision has ended its contract with BC/BS and with that, we will begin participating in the BC/BS Blue View Vision program. What this means, in short, is that we will continue to visit our eye professionals for vision programs, glasses and contacts, but we need to make sure that the providers use the BC/BS program. The network is actually much larger than the Davis Vision network, and you can search providers on EmpireBlue.com.

As far as the benefits of Blue View Vision, I believe most will be very happy to see a change in the structure of the plan. Specifically, we are now afforded an allowance to purchase glasses, different lenses, and contacts, rather than the

Davis program of purchase from a specific rack. We will now also enjoy tiered pricing on popular lens options and upgrades, 35-40% discounts on additional pairs of glasses, polycarbonate and transi-

tions lenses for children at no additional cost, and discounts on laser vision correction sur-

We have developed a plan benefit document that will be distributed to fully explain all of the benefits. This will be coming shortly. This plan takes effect July 1 as well. As we move forward more information will be coming, and if you have any questions as always feel free to contact us at the ATA office.

Continued from Page 2 becomes a resolution which NY-SUT will adopt as a priority for the coming year. Throughout the convention, these resolutions are brought before the whole body of delegates and debated as to whether they should be adopted, amended, or just let go.

The 2017 RA was particularly contentious, as the room was very clearly divided into two factions based around the Stronger Together and Unity Caucuses. (See the March 2017 issue of The Educator for background on this.) In the end, the Unity caucus generally prevailed, as they had many more members who

were in attendance at the convention. As in-person attendance be to rise in opposition to the at the RA is a requirement for voting in NYSUT elections, the Unity slate won all of the NYSUT officer positions its candidates ran for. As of April 10, NYSUT's President is Andrew Pallotta, its Executive Vice President is Jolene DiBrango, its First Vice President is J. Phillipe Abraham, its Second Vice President is Paul Pecorale, and its Secretary-Treasurer is Martin Messner. Messner and Pecorale previously held those positions, and Pallotta was previously the First Vice

Now that NYSUT's new officers have been installed, the fo-

cus for the coming months will possibility of a New York State Constitutional Convention. That is something that all NYSUT members, and all public sector union members, should agree on since opening the Constitution could threaten our pension benefits. In addition, a constitutional convention would be extremely costly, and jeopardize other rights that non-union citizens value. The ATA will be asking for all members to help spread the word to educate others as to why it will be important to vote against a Constitutional Convention next November.

On April 29 the ATA teamed up with its longtime partner, the Poughquag United Methodist Church, to do much needed repairs on their home. The event was organized by Rebuilding Together Dutchess County.

The threat of bad weather did not deter the fantastic turnout of our ATA members and their families. Representing the ATA this year were Betsy and Marc Denis, Kate Reid and Tom Hartford, Julie Jee, Kate Sprague-Hicks and John Hicks, Dan Braun, Ryan Pellow, Steve Kubicek, Maryann Markard, Renee Mavros and her son Dean, Doug Dickeson and retiree Bill McKeever. We had a total of 15 members, our biggest turnout to date.

After our morning safety meeting and coffee and donuts, the combined team this year installed new front steps and a new side

door, repaired the front door and basement door, painted, tore down a garage, did yard work, and porch column repairs, and installed smoke alarms, shower grab bars, a ramp to the shed, new columns in the basement and filled a 40 yard dumpster! There were probably other repairs done, but it was too hard to keep track! These repairs will provide a safe home for Mrs. Johnson and her son.

This year was a milestone for Rebuilding Together Dutchess County; it was their 25th year, serving our community. In those 25 years, 13,000 volunteers have completed 500 home repairs at a value of \$5.8 million to communities throughout Dutchess County. This valuable work the ATA is doing would not be possible if not for the Poughquag United Methodist Church, and we appreciate this partnership and their hospitality (you should have seen the lunch they provided.) Thank you to all who participated this year. I would also like to thank Jim DeBonis for helping me out with all of the mass emailing to our members.
