This year's school budget vote will take place on Tuesday, May 15. The ballot will also include three propositions and three school board candidates who are running unopposed.

The support of every ATA member is vital to ensure a positive outcome to the budget process. If you do not live in the district it is important that you talk to your friends and family who do and encourage them to get out and vote on the 15th. Make sure to tell them why passage of the budget and propositions are important to you and how they will benefit the children of this district.

This year's bus replacement proposition is the same as last year's. When school buses reach a certain age or number of miles NYS requires that they are replaced. Taxpayers are asked to permit the district to purchase new vehicles. This year, with 63% eligible for state transportation aid, the local share of the cost is \$693,195. If the bus proposition is not passed the district may have to lease buses. which will be more expensive.

#### **BUDGET FACTS**

MAY 2018

- A 2.20% tax levy increase is proposed, which is below the allowable 2.40% cap.
- If the budget fails twice, a contingency budget must be adopted, meaning that an additional \$3.0 million would have to be cut. That would require the elimination of new equipment purchases, and the reduction of positions, programs, and extracurricular activities, among other things.

#### AHS ATHLETIC COMPLEX UPGRADE PROPOSITION

In 2016 Arlington taxpayers approved a capital reserve fund to allow the district to set aside monies to use toward district facilities. This proposition will allow for the use of the remaining \$1.5 million from that fund to upgrade the AHS athletic complex and renovate some of the bathrooms at the high school with no additional increase to taxes.

#### CAPITAL RESERVE FUND 2018 PROPOSITION

The district is seeking approval to create a new capital reserve fund for \$20 million dollars. The maximum term of the fund will be 20 years. A capital reserve fund allows the district to set monies aside for the purpose of constructing additions, making improvements, and equipping district buildings and facilities. If this fails, capital projects will need to be fully bonded, which will result in new taxes.

One of the harbingers of spring each year is the NYSUT Representative Assembly (RA), where delegates representing local NYSUT chapters from all across the state convene for two days of business that includes debating changes to the NYSUT constitution and bylaws, and proposing resolutions to guide the efforts and direction of NYSUT's leadership in the coming year. These amendments and resolutions were proposed weeks prior to the RA, and committees convene to discuss and submit the changes to the entire voting body during general sessions. To add breaks to the debate and discussions, there are also quest speakers and reports from each NYSUT officer, as well as presentations of a variety of awards. In this delegate's perspective, this meeting in Buffalo on April 27 and 28 was much more calm and cooperative than the last two RA's which involved tension between two rival caucuses, and the turnover of leadership for the third time in the last dozen years. This year things were very settled, and the messages were unified. One of these messages is that NYSUT and the labor movement is gaining ground. State and national leaders touted grassroots campaigns and community action that drove the labor agenda. Pay raises in other states resulting from organizing and mobilizing

# Help Fix APPR

"Thanks to you, we are closer than ever to fixing New York's flawed and unfair teacher performance review law. The NYS Assembly has passed

A.10475, which would return control over teacher evaluations to local school districts and teachers. Between the Senate and the Assembly, this bill has more than 120 sponsors. That shows overwhelming support

for the bill, which would go a long way toward creating a fairer and more effective evaluation system.

It is now the Senate's turn to pass the bill. Let's aet this done now!"

State Senator Sue Serino represents much of the Arlington district, and she has not yet signed on to support the Senate bill. Please go to www.nysut.org/resources/ special-resources-sites/let -us-teach/fax to encourage her to do so.

In addition, we need to keep letting our lawmakers know that, while

this bill is a good start, it isn't enough. No system that uses any kind of student test scores to evaluate teachers is going to be fair, and APPR must be ended, not just amended.

## Rebuilding Our Community Together

Coffee, donuts, bagels, fruit...chicken marsala, chicken parmesan, ziti, sausage and peppers, bread ... cookies, brownies, and 2x4's? Sounds like a party!

On April 28 the ATA teamed up with our long time partners the Poughquag United Methodist Church to help out World War II veteran Frank Sause. This Rebuilding team was the largest to date: 48 in total, with 16 coming from the ATA, and providing a total of 417 hours worth of labor. Many of the ATA members were veterans of previous rebuilds, but with our numbers growing there were several new faces.

Sause has lived in this home for 63 years with much of the home still original; there was no shortage of work. The jobs consisted of a new front handrail, a repair to the garage door, mortaring bricks on the front steps and chimney, installation of new smoke and  $CO_2$  sensors, new basement stairs and railing, new door to the garage, new door out the basement, new door to the deck, repairs to

At the same time Sause was thanking the Rebuilding team for all their work, the team were all saying how we appreciated the fact that he served our country, and that we were happy to serve him in return. Sause put his hands out and with a big smile said, "Well, it was worth fighting for."
