### **Know Your Rights Under the Taylor Law**

From time to time, it's important to refresh ourselves regarding rights under the Taylor Law, which is the state law that sets the rules that govern collective bargaining and labor unions in New York's public sector. More specifically, individual members of collective bargaining units (such as the Arlington Teachers' Association) have the right to engage with fellow employees about their terms and conditions of employment.

Section 202 of the Taylor Law says "public employees shall have the right to form, join and participate in, or to refrain from forming, joining, or participating in, any employee organization of their last thing the ATA wants to own choosing." In other words, members of the ATA have the right to talk

to one another about things such as the collective bargaining agreement, contract negotiations, supervisory and administration issues, and potential or actual discipline.

Fully recognizing these rights, the ATA has in the past advised bargaining unit members, and will continue to so advise in the future, that it is in their to interfere with, restrain best interests in some instances and under certain circumstances to refrain from discussing (whether in person or on social media) certain matters, such as confidential human resource issues. When the ATA issues such advice, it does so only with your best interests in mind. The see is members of its bargaining unit subjected to potential counseling or dis-

ciplinary charges (or immediate discharge in the case of those who are not tenured) for discussing things that are considered by the District to be confidential or sensitive in nature.

When the ATA gives you such advice, it is just that—advice; it is not a directive that is intended or coerce your rights. At all times you retain your rights under the Taylor Law to discuss such matters notwithstanding the ATA's advice. However, if vou choose to janore the ATA's advice, and while the ATA would never retaliate against you for doing so, you do run the risk of having action taken against you by the District.

Tax Season Is Upon Us Once Again

Dues Deductions for the Calendar Year 2019 for:

Full Time Teachers Who Were Employed In All Of 2019: \$951 Full Time Teachers Who Started In September 2018: \$357 Full Time Teachers Who Retired In June 2019: \$594

Please note: ALL full time teachers pay the same amount of union dues.

Dues deductions begin in October, and continue for 15 pay periods, ending in April or May.

ATA members have the option of having dues deducted over the first 6 or 10 pay periods, but very few individuals choose these options. If you are interested you can contact the payroll office to change your deduction timeline.

You may have a different amount taken out if you are part-time or were out on extended leave. Check your pay stub from the last paycheck in December for your exact amount, as well as other potential tax deductions. Check with your tax preparation professional to discuss your work related deductions.

grading when we have so many other more important issues to tackle.

Please rest assured the ATA will continue to lead in this effort. As the budget season starts, there are greater conversations of the need in certain areas, while we try to slow the elimination of other positions in the name of "rightsizing". It is our hope that we could lower our class sizes and begin to have an opportunity to build greater relationships with students and their families. This would be paramount to building a more community-based school district. It is through your hard work each day that our dedication to our students shows. I know it is challenging at times, but understand the effort is obvious.

What 2020 will bring is going to be interesting. This is a big election year, and a challenging budget year for the State of New York. As the superintendent has expressed, there will be a

significant budget shortfall as they begin to build next year's budget. This may cause the district some challenges, but we have weathered much worse in the past. Please pay a greater attention to the process, and we will try to keep you informed as well.

As I began this article I made reference to the professionals who were here before us. We are so very fortunate to have inherited what we have in the District and the ATA from the efforts of our retirees. It is our responsibility now to foster positive change that will be the basis for this district

and our profession into the future. Education is ever changing, we have all witnessed it, engaged it, and worked through it. The focus we need to keep is that of what is best for our students. I believe no one knows this better than us, the professionals who work day to day with these young people. Please continue to be vocal of your concerns. We need to be the drivers of change, not the passengers to the process.
