Support Your Schools On May 17

This year's school budget vote will take place on Tuesday, May 17. The ballot will also include transportation and maintenance propositions and three school board positions.

The support of every ATA member is vital to ensure a positive outcome to the budget process. If you do not live in the district it is important that you talk to your friends and family who do and encourage them to get out and vote on the 17th. Make sure to tell them why passage of the budget and the propositions are important to you and how they will benefit the children of this district.

In addition, offer to give them information

about the candidates for school board and explain why it is important for the success of the district to have people on the school board who are able to work with the employees of Arlington to further the educational opportunities that we offer. There are several qualified candidates running, and the ATA has carefully considered whom to endorse. More information about this is on the next page.

To the right and below you will find some facts to help you inform others about the 2022—2023 Arlington school budget and propositions. More information about these items can be found at arlingtonschools.org.

BUDGET FACTS

- A 1.95% tax levy increase is proposed, which is below the allowable 2.99% cap.
- If the budget fails twice, a contingency budget must be adopted, meaning that an additional \$6.3 million would have to be cut. That would require the elimination of new equipment purchases, and the reduction of positions, programs, and extracurricular activities, among other things.
- Proposition #2 is for the purchase of bus and equipment replacements in order to provide cost predictability. If this proposition does not pass, more buses will likely need repairs as they get older, which could lead to cuts to educational programs to cover these additional costs.
- Proposition #3 is a building maintenance proposition for \$21.5 million to fix the roofs and sidewalks at Arlington High, Union Vale Middle, and Vail Farm Elementary Schools.

for Liberty, a national organization with ties to extreme right-wing elected and the Arlington officials, media outlets, and organizations. No matter how friendly and community-minded these candidates may seem, they have willingly chosen to be connected to a group whose founder has explained that their goal is to take over school boards and replace school

employees with those found by "conservative search firms". Moms for Liberty espouses limiting what is taught in classrooms and censoring libraries, all in the name of parental rights. Our local candidates can not be decoupled from the mission of their backer.

YSUT RA Celebrates 50th Anniversary

After two years of virtual conventions, NYSUT was able to convene the first post-COVID, in-person Representative Assembly (RA) on Friday April1 and Saturday April 2 at the Albany Convention Center. The purpose of the RA is to allow about 1500 delegates from local unions to come together and work in committees to craft the resolutions that guide the priorities and direction for NYSUT to follow in the coming year.

Treasurer Dave Cordella and Second VP Steve Hertzog represented the ATA at this year's RA. The whole group of delegates meets in several "general sessions" to discuss and vote on these resolutions. The general sessions also have an "award show" component, as well as speeches from union leaders and politicians who want to address the RA delegates. This year's guest speakers included Governor Kathy Hochul, who was greeted with a standing ovation as she took a break from the nonstop state budget negotiations to deliver a lively and positive recognition for the work that NYSUT members, and a promise that "the era of disinvestment in education is over". Hochul supports public schools as a key structure to drive social mobility and build communities.

NY comptroller Tom DiNapoli delivered his perennial confirmation that our pension fund is strong and secure, and enthusiastically praised the work of NYSUT members as well. Organized labor has a strong



Labor leaders who came to fire up the crowd included AFT President Randi Weingarten, NEA President Becky Pringle, and NYS AFL/CIO

President Mario Cilento.

The 2022 RA celebrated the 50th Anniversary for NYSUT, which whole convention.
