Fighting For Our Union Family

Continued from front System. More information will be coming, but the campaign is on to influence our legislators to change the laws that created Tier 6. For those of us in the profession for a long time, we started in Tier 4 and at that time we had tier envy for the Tier 1 folks. They really did have a very sweet retirement set up, but keep in mind, salaries were not equitable with other professionals in the business world, so their retirement was relative to what they had earned. Today, the cost-ofliving adjustments (COLAs) have kept them afloat in retirement. It needs to be noted the Tier 1 folks successfully fought for changes for us in Tier 4. This is where I hope you will pay attention.

The different aspects today for our Tier 6 colleagues are significant and should be noted. Tier 4 was required to pay 3% of salary toward our pensions, and that was shortened to a 10vear period through the work of NYSUT, lobbying our lawmakers, VOTE COPE contributions, and the political pressure our members applied. Today Tier 6 members will pay up to 6% of their salary their entire career with the contributions growing as the work we did was important, their salary grows. The real issue will be years down the road. For those of us who started early in life, the rule has been 30 years of service at age 55 and you were eligible to retire. With less than 30 years you would have to work until 62 and you could retire without penalty to your pension. The Tier 6 folks will have to work to age 63 with 40 years of service or face heavy

penalties. In real numbers, a Tier 4 member retiring with 30 years of service at age 55 would receive 60% of their final average salary. significantly reduced pension. It is also unreasonable in our society that we would not afford our young members the same dignity in their retirement that older members have all earned and look forward to. Entering in public service we all knew that and we would never get rich on our salaries. Today we earn a solid income as professionals, but the legislation that created Tier 6 needs to be revisited by our legislature, and we the membership have the votes to make that happen. More information will be coming, but you can enter the conversation by visiting Fixtier6.org. This is a NYSUT website with a wealth of

information to educate vourself about this movement that is growing to support our newest members.

Now in the next few months there will be significant efforts to build a positive future in Arlington. I am sure you are all search for a new superintendent, again. The ATA hopes to work with the board of education to find a forward-thinking individual who appreciates what makes us Arlington, without trying to

> reinvent us in their image. We will also be asked to support the district's bond referendum to bring renovations and improvements to many of our schools. It is unfortunate, but many of our buildings are in desperate need for upgrades and improvements to provide a more equitable educational experience for our students across the district.

As always, the ATA leadership is poised to engage and work to have the best possible outcomes in these endeavors. There is a lot of work ahead, but we are up for the task. Thank you for the continued support in our efforts. I want to thank you all for the work you do every day that makes Arlington what it is. It is clear-we are Arlington, and as leaders come and go, it is the faculty and staff that carry forward our traditions and culture. Tax Season Is Upon Us Once Again

When preparing your taxes, you may be able to deduct the union dues from your taxable income. Check with your tax preparation professional to be sure.

So how much did I pay in Union Dues (ATA+NYSUT/NEA+AFT) in 2023?

New employees (started in September)	\$362.64
Full time employees (worked last year also)	\$900.40
Recent retirees (Dues from last spring)	\$537.76

Are there any exceptions to this? Yes, a few people may have had a leave, or started after Sept. 1, or had some other payroll interruption that would change their deduction. See below to confirm your deduction.

The documentation you can provide to show that you have made these payments is on the "paystub" that was emailed to you on 12/21/23. The line to look at is *DUES ATA*, in the *Cal Year To Date* column. I recommend keeping all of your paystubs, but the last one in each December is particularly handy when tax prep time comes.

Spotlight on the Contract: Outside the Classroom

The Educator periodically spotlights a particular part of our contract in an effort to make our members more familiar with their rights and the terms and conditions of their employment. If you have a section you would like to see featured, email sfalk@acsdny.org.

"The private and personal life of a teacher is not within the appropriate concern or attention of the Board or Administration except as it may interfere with the teacher's responsibilities to and relationships with students or the school system or impair his/her ability to fulfill his/her teaching duties."

"Teacher participation or non-participation in voluntary extra-curricular, community, church, club or social activities shall not be considered in evaluating teacher performance."

Explanation: These provisions (Article VI, page 8, and Article XIV, page 19, respectively) together say that what teachers do outside of the classroom is not to be considered during any evaluation process, as long as their activities do not interfere with teaching duties. Teachers should not be discriminated against due to lifestyle choices. In addition, their participation in any community or extra-curricular activities at school cannot be taken in to account by administrators when evaluating a teacher, such as for tenure.

Announcements

Do you have educator expenses to deduct from your taxes?

Eligible educators can deduct up to \$300 of qualified expenses paid in 2023. Spouses who are eligible educators filing jointly can deduct up to \$600. To be eligible you must have worked at least 900 hours in a school during the school year. Qualified expenses include books, supplies, equipment (including computer equipment, software, and services), and other materials used in the classroom; PD courses; personal protective equipment, disinfectant, and other supplies used for the prevention of the spread of COVID-19.
