Negotiations Update: Misconceptions Addressed

We have received 200 submissions through the Google Form for contract proposals. Although there are many repeated ideas, that's still a lot. Thank you for sharing your ideas. I just wanted to take this opportunity to clear up a couple misconceptions that I noticed in the proposals...

Misconception: Elementary teachers at other districts, for example, New Paltz, are paid more than secondary teachers.

This lacks evidence. I read through the New Paltz teacher contract after a few people mentioned this in their submissions and found no language that would support that assertion.

Misconception: Building and/or district coordinators receive longevity pay in addition to their base stipend.

False. There are two types of longevity pay in the contract. The first, which applies to everyone, kicks in at years 23, 26, and 29 and is added to your base salary. The second only applies to coaches and people receiving stipends for extra-curriculars activities. They get a 5% increase after 5 years of service as coach/advisor and a 10% increase after 10 years of service.

Misconception: Members on maternity leave who are using their sick days are not paid.

False. Anytime a member is using a sick day or the sick bank, either for illness or maternity leave, they are paid their normal rate of pay and receive benefits.

Misconception: We work 187 days a year, more than every district around us.

False: While there are 187 work days on the calendar, we work 183 days a year. This is a result of our four emergency days, which end up either as snow days or give-back days. This is in line with what other nearby districts work.

Misconception: The existence of Regents testing days at the high school impacts the number of hours that elementary and middle school teachers are required to work.

False. Regents testing days count toward the required 990-hour state requirement for minimum instructional time and have no impact on the elementary or middle schools.

Tax Season Is Upon Us Once Again

When preparing your taxes, you may be able to deduct the union dues from your taxable income.

So how much did I pay in Union Dues (ATA+NYSUT/NEA+AFT) in 2024?

New employees (started in September)	\$426.86
Full time employees (worked last year also)	\$970.88
Recent retirees (Dues from last spring)	\$544.02

Are there any exceptions to this? Yes, a few people may have had a leave, or started after Sept. 1, or had some other payroll interruption that would change their deduction. See below to confirm your deduction.

The documentation you can provide to show that you have made these payments is on the "paystub" that was emailed to you on 12/26/24. The line to look at is DUES ATA, in the Cal Year To Date column. I recommend keeping all of your paystubs, but the last one in each December is particularly handy when tax prep time comes.

Have you done the mandated reporter of child abuse training yet?

NYS now requires all certified employees to complete this training by April 1, 2025. Register for the free online course at www.nysmandatedreporter.org/TrainingCourses.aspx.

Do you have educator expenses to deduct from your taxes?

Eligible educators can deduct up to \$300 of qualified expenses paid in 2024. Spouses who are eligible educators filing jointly can deduct up to \$600. To be eligible you must have worked at least 900 hours in a school during the school year. Qualified expenses include books, supplies, equipment (including computer equipment, software, and services), and other materials used in the classroom; PD courses; personal protective equipment, disinfectant, and other supplies used for the prevention of the spread of COVID-19.
